This is an explanatory statement given to all shareholder of the Company relating to a resolution to be proposed at the Annual General Meeting authorizing the Repurchase Mandate.

This explanatory statement contains all the information required pursuant to rule 13.08 and other relevant provisions of the GEM Listing Rules which are set out as follows:

## 1. EXERCISE OF THE REPURCHASE MANDATE

As at the Latest Practicable Date, the issued share capital of the Company was HK\$4,864,320 comprising 486,432,000 ordinary Shares of HK\$0.10 each. Exercise in full of the Repurchase Mandate, on the basis that no further securities are issued or repurchased prior to the date of the Annual General Meeting would result in up to 48,643,200 Shares, being 10% of the issued share capital of the Company, being repurchased by the Company.
