In the case of joint holders, any one of such joint holders may vote at the 2010 AGM, either personally or by proxy, but if more than one of such joint holders be present at the 2010 AGM personally or by proxy, that one of the said persons whose name stands first on the register of shareholders of the Company, in respect of the relevant shares shall alone be entitled to vote in respect thereof.
