ENTERTAINMENT ELETRONIC VIDEO LOTTERY TERMINALS
IN HAINAN

The Board hereby announces that Huancai Puda, a subsidiary of the Company, won the open bid for the procurement of lottery terminals for Hainan Provincial Sports Lottery Administration Centre.

This announcement is made by China Netcom Technology Holdings Limited (the “**Company**”) on a voluntary basis in order to update the business development status of the Company together with its subsidiaries (collectively, the “**Group**”).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company hereby announces that, Shenzhen Huancai Puda Technology Company Limited* (深圳環彩普達科技有限公司) (the “**Huancai Puda**”), a subsidiary of the Company, won the open bid for the procurement of sports entertainment electronic video lottery terminals (“**VLT**”). The supply contract will be executed with Hainan Provincial Sports Lottery Administration Centre.

Hainan Province is a well-known international tourist island in the People’s Republic of China (the “**PRC**”), and has served approximately 36 million visitors in 2013. As a special economic zone, Hainan Province enjoys special national policies and Hainan Provincial Sports Lottery Administration Centre is the only official lottery agency in Hainan Province, which is responsible for the coordination and management of the sale and distribution of lottery in Hainan Province.

The Group acts as the sales agent for the sale of lottery game “Happy 12” in Liaoning Province and has been operating the sales points for lottery games in Shenyang, Dalian, Jinzhou and Panjin of Liaoning province in the PRC. As stated in the 2014 first quarterly report, the Group will continue to adopt an active and prudent strategy, and keep looking for projects of the PRC’s lottery industry as well as other opportunities in line with China’s development of 12th Five-Year Plan.
