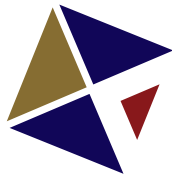

PARTIAL EARLY REDEMPTION OF CONVERTIBLE BONDS

Reference is made to the Company's announcements dated 13 October 2010, 16 November 2010, 25 November 2010, 25 May 2011, 9 June 2011, 6 September 2011, 30 September 2011 and 31 October 2011 (the "**Announcements**") relating to the Convertible Bonds. Unless otherwise stated, capitalized terms used herein shall have the same meaning as defined in the Announcements.

By mutual agreement between the Company and the Vendor, the Company has further early redeemed part of the Convertible Bonds (the "**Redemption**") in the amount of HK\$10 million on 8 November 2011, which has been satisfied by the internal resources of the Group. The Board considers that the Redemption can reduce the Company's debt position and the ongoing interest costs and therefore it is in the interests of the Company and its shareholders as a whole.

Following and as a result of the redemption in the aforesaid amount of HK\$10 million Convertible Bonds, the outstanding amount due by the Company to the Vendor under the Convertible Bonds is HK\$20 million.
