*** The Company has early redeemed part of the Convertible Bonds in amount of HK\$50 million on 6 September 2011 and HK\$20 million on 30 September 2011 respectively.

**** The conversion price of the Convertible Bonds was adjusted from HK\$0.83 per Share to HK\$24.90 per Consolidated Share after the Consolidation of Shares effective on 14 September 2011.
